Pupil Premium Strategy

2020-2021

Pupil Premium is a specific allocation of funds, additional to main school funding, which the Government believes is the best way to address the current underlying inequalities between children who are in receipt of free school meals and those that are not. The Government believes that the allocation of Pupil premium will tackle disadvantage by reaching the pupils who need it the most and diminishing the difference between their attainment and progress and those of their peers.

Pupil Premium Allocation for 2020-21 is £40,005

Key barriers facing disadvantaged pupils:

- 1. Poor emotional wellbeing factors such as low self-esteem and lack of confidence
- 2. Additional needs such as ADHD, dyslexia or mild learning difficulties
- 3. Poorer than average attendance [frequent ill health, unauthorised holidays or days out of school]
- 4. Lack of parental support Parents less able to support out of school learning for children with single parents / large families, where there are behavioural issues or where parents have learning difficulties or disabilities
