# School Offer for Children with Special Educational Needs

All Dronfield schools have a similar approach to meeting the needs of pupils with Special Educational Needs and are supported by the Local Authority to ensure that all pupils, regardless of their specific needs, make the best possible progress in school. All schools are supported to be as inclusive as possible, with the needs of pupils with a Special Educational Need(s) and or disabilities being met in a mainstream setting wherever possible, where families want this to happen.

Teaching Assistants (TA)	A teaching assistant may be allocated to a pupil with exceptional special educational needs and/or disabilities and whilst they take a very valuable role in your child's education we would prefer that questions regarding your child's learning and progress are directed in the first instance to the staff members named above. Of course, as a school we welcome daily dialogue between parents and TAs on how a child's day has been and we do actively encourage this continued feedback.

### B. HOW COULD MY CHILD GET HELP IN SCHOOL?

Children in school will get support that is specific to their individual needs. This may be all provided by the class teacher or may involve:

- Other staff in the school
- Staff who will visit the school from the Local Authority central services such as the ASD Outreach Team, Educational psychologist or Sensory Service (for students with a hearing or visual need)
- Staff who visit from outside agencies such as the Speech and Language Therapy (SALT) Service.

How can I let the school know I am concerned about my child's progress in school?	<ul> <li>If you have concerns about your child's progress you should speak to your child's class teacher initially.</li> <li>If you are not happy that the concerns are being managed and that your child is still not making progress you should speak to the SENDCO or Headteacher.</li> <li>If you still have concerns you can speak to the school SEND Governor.</li> </ul>
How will the school let me know if they have any concerns about my child's learning in school?	<ul> <li>When a teacher or a parent has raised concerns about your child's progress, and targeted teaching has not met the child's needs, the teacher will raise this with the SENDCO.</li> <li>Schools also have meetings every term between each class teacher and a senior staff member in the school to ensure all children are making good progress. This is another way your child may be identified as not making as much progress as expected.</li> <li>If your child is then identified as not making expected progress the school will make a decision about whether to monitor this or set up an intervention group and will inform you.</li> <li>If your child is still not making expected progress the school will discuss with you: <ul> <li>any concerns you may have</li> <li>any further interventions or referrals to outside professionals to support your child's learning</li> <li>how school and home can work together, to support your child.</li> </ul> </li> </ul>
How is extra support allocated to children and how do they move between the different levels?	<ul> <li>The school budget, received from Derbyshire LA, includes money for supporting children with SEND.</li> <li>The Headteacher decides on the budget for Special Educational Needs in consultation with the school governors, on the basis of the needs of the children currently in the school.</li> <li>The Headteacher and the SENDCO discuss all the information they have about SEND in the school, including:         <ul> <li>the children getting extra support already</li> <li>the children needing extra support</li> </ul> </li> </ul>

and what training do they have?	<ul> <li>whole school training on SEND issues or to support identified groups of learners in school, such as ASD or dyslexia.</li> <li>Whole staff training to disseminate knowledge, strategies and experience, to ensure consistency of the school's approach for children with a SEND.</li> <li>Individual teachers and support staff attend training courses run by outside agencies that are relevant to the needs of specific children in their class e.g from the ASD Outreach service and Sensory service or medical /health training to support staff in implementing care plans.</li> <li>Training takes place on a regular basis. If you would like to hear about the training which is currently taking place or has taken place by the staff members in the school, please speak to the Headteacher or SENDCO.</li> </ul>
How will the teaching be adapted for my child with learning needs (SEN/ and or disabilities)	<ul> <li>Class Teachers plan lessons according to the specific needs of all groups of children in their class, and will ensure that learning tasks are adjusted in order to enable your child to access their learning as independently as possible.</li> <li>Specially trained support staff can implement the teachers modified/adapted planning to support the needs of your child where necessary.</li> <li>Specific resources and strategies will be used to support your child individually and in groups.</li> <li>Planning and teaching will be adapted on a daily basis if needed to meet your child's learning needs and increase your child's access to what is on offer.</li> </ul>
How will we measure the progress of your child in school? And how will I know about this?	<ul> <li>Your child's progress is continually monitored by his/her class teacher.</li> <li>His/her progress is reviewed formally every term and a National Curriculum level or equivalent given in Reading, Writing, Maths as well as progress in other areas, as appropriate, such as attendance, engagement in learning and behaviour.</li> <li>At the end of key stage 2 (year 6) all children are required to be formally assessed using Standard</li> </ul>

	<ul> <li>Assessment Tests (SATS). This is something the government requires all schools to do and are the results that are published nationally.</li> <li>The progress of children with a statement of SEN/ EHC Plan is formally reviewed at an Annual Review with all adults involved with the child's education.</li> <li>A range of ways will be used to keep you informed, which may include: <ul> <li>Home/school book</li> <li>Letters/certificates sent home</li> <li>Additional meetings as required</li> <li>Reports</li> </ul> </li> </ul>

What support do we have for you as a parent of child with an SEN/and or disabilities?

- We would like you to talk to your child's class teacher regularly so we know what they are doing at home and we can tell you about what we are doing in school. This is to ensure that we are doing similar things to support them both at home and school and can share what is working in both places. Parent evenings take place regularly throughout the year where any Individual Education Plans (IEP's) can be shared.
- All information from outside professionals will be discussed with you with the person involved directly, or where this is not possible, in a report. The SENDCO will also arrange to meet with you to discuss any new assessments and ideas suggested by outside agencies for your child.
- Homework will be adjusted as needed to your child's individual needs.
- A home/school contact book may be used to support communication with you, when this has been agreed to be useful for you and your child.

### In addition:

If you child is undergoing EHCP assessment, you will also be supported by the school and Local Authority. They will ensure that you fully understand the process.

How have we made this school physically accessible to children with SEND?	<ul> <li>The school is as accessible as it can be, given that it is built on 3 levels, to children with physical disability. The LA have some limited resources for providing adaptations necessary should pupils with physical disabilities be admitted. There is also an accessibility plan.</li> <li>We ensure that equipment used is accessible to all children regardless of their needs.</li> </ul>

How will we support your child when they are leaving this school? OR	We recognise that 'moving on' can be difficult for a child with SEN/and or disabilities and take steps to ensure that any transition is a smooth as possible.
